COMMUNITY AND HOUSING PROGRAMS

CDBG Programs are funded through U.S. Department of Housing and Urban Development (HUD)

- Community Development Block Grant (24 CFR Part 570)
 - Entitlement
 - Discretionary
- Community Development Block Grant Disaster Recovery (CDBG-DR)
- Community Development Block Grant CARES ACT (CDBG-CV)
- Section 108 Loans



CDBG PURPOSE

- Supports community development activities to build stronger and more resilient communities
 - Twenty-six (26) activity types addressing needs in 6 broad categories:
 - Public Infrastructure/Facilities
 - Water, sewer, roads; etc
 - Housing
 - Clearance of blighted structures
 - Code Enforcement
 - Public Services, and more



NATIONAL OBJECTIVES

Projects must meet one of three National Objectives

- Benefit to low- and moderate- income persons (LMI)
- 2. Aid in the prevention or elimination of slums or blight (S/B)
- 3. Meet a need having a particular urgency (urgent need) (U/N)



FY 2024 CDBG allocation breakdown:


Total allocation: \$40.8M

- Entitlement communities: \$34.66M
 - 38% to eligible counties
 - 38% to eligible boroughs and townships
 - 24% to eligible cities
- Competitive awards: \$4.89M (12%)
- Admin & Technical Assistance (TA): \$1.22M (3%)



- DCED is authorized to administer this program under Pennsylvania Law known as Act 179 of 1984
- DCED provides CDBG funding for the smaller communities and rural areas of the Commonwealth that do not receive HUD funding directly
- Entitlements must apply annually

PA CDBG Act 179 Communities





WHAT DOES THAT LOOK LIKE?

- Review 82 applications each year for 190 grantees
 - Evaluate for compliance with citizen participation requirements
 - Capacity
 - Timeliness
 - Community Development Plan
 - Activity eligibility
 - National Objective
- Average number of activities per application: 5



CDBG DISCRETIONARY

- 12% of the annual CDBG allocation is reserved for CDBG Discretionary (Competitive)
 - Eligible applicants are units of local government
 - Minimum request is \$100,000 (no maximum)
 - Applications typically due February of each year
- DCED Priorities
 - Water and Sewer Projects that impact health and safety of residents
 - 2. Community Revitalization
 - 3. Public Services
 - 4. Resiliency Projects
 - Green infrastructure, storm water management, wetlands management to lessen impacts from natural disasters



COMMUNITY DEVELOPMENT BLOCK GRANT CARES ACT (CDBG-CV)



CDBG-CV PURPOSE

Same mission on CDBG annual funds plus

Each assisted activity <u>"prepares, prevents, and</u> <u>responds to coronavirus</u>"

All twenty-six (26) activity types are eligible. We have seen a particular interest in:

- Small Business Grants
- Assisting non-profits (Food Banks)
- Water system and Park Improvements



CDBG-CV allocation breakdown:

Total allocation: \$96.1M

- Non-entitlement communities: \$23.9M
 - 38% to eligible counties
 - 38% to eligible boroughs, incorporated towns, and townships
 - 24% to eligible cities
- Competitive awards: \$65.7M
- Admin & Technical Assistance (TA): \$5.7M



COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY (CDBG-DR)



CDBG-DR PURPOSE

To support long-term recovery efforts following a disaster

Activities include

- Housing Rehab/Reconstruction
- Housing Acquisition and Buyout
- Multi Family Rental Rehab
- Infrastructure
- Mitigation



CDBG-DR FUNDING

- \$57M in 2011 from damage caused by Tropical Storm Lee and Hurricane Irene
- \$38M in 2021 from damage caused by Hurricane Ida
- Funding is issued by HUD when there is a Presidential Disaster Declaration and specific geographic regions are often identified



CDBG-DR FUNDING

- Funding for Ida identified the following eligible counties
 - Bedford
 - Bucks
 - Chester
 - Delaware
 - Montgomery
 - York
- Funding awards are made through a competitive application process



SECTION 108 LOANS



SECTION 108 LOAN PROGRAM OVERVIEW

- Enables states and local governments participating in the Community Development Block Grant (CDBG) program to obtain federally guaranteed loans to fund large economic development projects and undertake revitalization activities.
- Under Pennsylvania's initiative to use Section 108, the loans are guaranteed by the Commonwealth, committing the use of future CDBG funds to pay off the loan in case of default.
